1. Apologies for Absence

Apologies were received from Councillor P Daimond.

2. Disclosable Pecuniary Interests

3. To approve the minutes of the Parish Council Meeting held on 25 March 2024

Address: Proposed Residential Development Land To The South of Uffington Shrewsbury

Description: Erection of one detached dwelling with further detached garage/pool building and detached stables block and change of use of adjacent land to private amenity land together with erection of boundary walling and fencing and the creation of one new residential access and one new field access.
